How to decide?

How much you give is of course a personal decision, based on your resources, the priority of UUCPA within your other giving plans, and so on. Here are some models for making giving decisions.

1. Give more than zero

We the members of UUCPA have defined "Membership" as requiring a "contribution of record" each year. A contribution of record is any non-zero donation sumitted to the church office with your name on it. As a practical matter, we ask all members to pledge at least one dollar, even if you'll give only one cent.

People who do not wish the obligation to donate money are welcome as "Friends" of UUCPA. It turns out that some friends do choose to donate, and to make annual pledges. If that is what you wish to do, we welcome that.

2. Give more than a fair price

Compare what you get from UUCPA to what you get from a movie, or a good night out. Now compare how much you give to UUCPA for that service, or class, or fellowship. Do you support UUCPA at least as well as you support theatres and restaurants? But don't stop there. Because the church gives freely to all, those of us who donate must donate more than the "fair price", to provide for the others.

3. Give a social justice tithe

Part of our work at UUCPA is to live our lives according to our own values. Does your use of money reflect your values, as in a donation to a cause that enacts your values in the world, or is it independent of your values, as in, say, a new pair of shoes? Set yourelf a target of giving a social justice tithe.

A social justice tithe means giving at least 10% of your income to some combination of the UUCPA operating pledge, building fund, other charities, and political groups that enact your values.

We invite all **Social Justice Tithers** to note this on their Membership Renewal letter, so that we can celebrate your generosity.

4. Give a Sustaining or Supporting Gift

The work of generosity is relative to your resources. A small gift may be generous if you have little income. A large gift may be nothing if you are wealthy. The UUA has defined "Suggested Share" giving levels (see table above). Look up your income and target level on this table, and see how much that comes to.

We invite all **Supporting** and **Sustaining** givers to note this on their Membership Renewal letter, so that we can celebrate your generosity.

5. Be a Leadership Giver for UUCPA

UUCPA has generous members, and large (and expensive) ambitions. On the back of the brochure is an **ambitious gift profile** that represents meeting all of UUCPA's forecast needs for our coming year, with no deficit. Find a gift level on that table that is a stretch for you, that will help you feel good about supporting UUCPA as it does its good work in the world.

6. Give to enact your values

Give generously. Give without being limited by what others do. Give enough that you feel it. Give in a way that your money can go out into the world and enact your values. Give in a way that brings joy and satisfaction to your heart, and makes generosity a part of your spiritual path.

The UUA Fair Measure of Gross Income

We have a diverse congregation, everyone from Silicon Valley millionaires to families paying for children and elderly parents to retirees on fixed incomes. Here's a fair way of figuring your gross income, so that you can set yourself giving goals relative to your income.

An Ambitious Gift Profile

This table reflects the kind of gifts we would need to give in order to meet the payroll we already have, to put on the programs we already do, all without a deficit. In other words, it is relative to UUCPA's present needs.

You can use this table in two ways:

- 1. Think where in the church's donor base you want to be, for instance in the solid middle, or leading at the top. Look up the amount matching that level.
- 2. Think of the amount you would like to donate. Look up where in the pledge profile that puts you.

How is this different from our giving in 2001-02? It represents all 137 members who pledged nothing starting to pledge something; new members pledging for the first time; many people substantially increasing their pledges; and raising the ceiling on our top "leadership" pledges.

It takes all kinds of gifts, large and small, to achieve this kind of ambitious donor profile. But we are capable of it. A 2001 congregational survey showed that we have a median income of approximately \$100,000 per household. Across 400+ members, that's a lot of resources. Between us, we have the means.
